Fees for studies

What can the University charge us for?

Pursuant to the Act, the university may charge fees only for:

- part-time study;
- repeating classes or stages (the so-called conditions or repeating a semester or year);
- studies in a foreign language;
- activities outside the study program (e.g. extracurricular foreign language classes);
- educating foreigners in full-time studies in a foreign language;
- enrollment for studies (recruitment fee);
- confirmation of learning outcomes (e.g. when a student wants their professional achievements to be recognized as an equivalent of a given subject);
- issuing a diploma;
- use of canteens and dormitories;

How much does a condition or repeating a stage cost?

Fees for the so-called educational services can be checked in the table of fees (price list) available at the [website](#). There, students can check fees according to the category, i.e. we will find information that repeating 30-hour exercises will cost a certain amount. The price list is subject to an opinion from the Student Council.

Fees for studies

Is it possible to be exempt from the fee?

Yes, it is possible to apply for an exemption from part or all of the fee or to divide it into installments, e.g. tuition fees, fees for repeating a subject or a year – an application documented in such a way is sent to HTU. The issues of exemption from fees are regulated in a separate document – Order No. 130 of the Rector of the University of Warsaw of September 30, 2019.

When can you apply for the fee exemption?

According to the Rector's Ordinance, the basis for exemption from the fee in part or in full, or by dividing it into installments, may be in particular:

- good academic performance
- outstanding scientific achievements
- outstanding sports achievements in competition, at least on a national level
- significant downturn of student's financial situation during studies
- important social considerations justifying the support of the student due to his unique personal situation
- particularly important social activity of the student for the University of Warsaw

In the case of matters related to the downturn of the financial situation, such a request should be submitted no later than 3 months from the date of such event. In other cases, no later than 30 days before the commencement of classes being the subject of the application. Applications in these matters are not accepted in December.

Fees for studies

What are the payment deadlines?

The deadlines for paying the fees are set by HTU. At the same time, persons taking a student loan can pay the fees in installments on the date when the loan tranches are received, after documenting the order for the bank to transfer the loan tranches to the UW bank account.

Can the amount of fees change during studies?

No, according to the Act, fees must remain the same for a given year of students, except for university canteen fees and dormitory fees – these can be changed on a regular basis. In addition, an exception is for example, going on an annual leave or repeating the year. It should be taken into consideration that after returning from such a leave or when repeating the year, the fee rates we will be charged are going to be the same as for the lower year, and not for the year with which we started our studies.
